# 1. What is Homestay?

A homestay (or home-let) scheme enables residents to let out a single room, multiple rooms or their entire home to visitors short term.

# 2. The Benefits of Homestay

Homestay offers benefits to both residents and visitors:

- Visitors have a wider selection of accommodation to chose from
- Visitors get a better feel for local life in the area
- Visitors benefit from more homely, more affordable, accommodation rather than the corporate hotel offer
- Residents can play a direct role in major events such as the Olympics
- Residents can meet interesting people from all over the world
- Residents can share their love and enthusiasm for the local area

A homestay scheme also benefits the local economy by:

- Increasing the accommodation offer in the local area
- Filling the gap in accommodation supply, particularly the short term gap created by big events which temporarily increase the number of visitors to an area
- Encouraging visitors into less typical visitor areas where there are fewer hotels

# 3. Guidance for Visitors Renting Homestay Accommodation

# 3a. Your Entitlements as a Homestay Guest

As a guest in homestay accommodation, you can reasonably expect the following:

- Clean, furnished, private rooms with lock/bolt/
- Hot water at all times
- Access to either private or shared bathroom with toilet, bath/shower, washbasin and hot and cold running water.
- Information on arrival/ departure arrangements
- Details of local transport and parking options
- A key / access code to the property
- Windows that open
- Space for clothes storage
- Details of fire escape

## 3b. Your Responsibilities as a House Guest

- To respect the host, property and house rules
- To pay agreed price, on time
- To leave the property as you find it
- To admit to any damages caused

## 3c. Potential Risks of Choosing Homestay Accommodation

- Poor accommodation standards
- Personal safety
- Risk to property
